Objectives of the Committee:

- **■** To Monitor the day-today functioning of the Institution.
- To identify work practices which are conducive to the efficient functioning of the campus.
- To examine the availability of financial resources and infrastructure.
- To provide for setting out the practices regime or right to Information for Citizens to secure access to information.
- To promote accountability and transparency in the smooth and effective functioning of the Institution.

Powers and Duties of the Committee members:

- 1. PIO- Principal: She is the Chief Representative of the management and Head of the College. She looks into the whole functioning of the institution and is responsible for the overall affairs of the college. All citizens shall have the right to information accessible and hence the PIO attends to the rights of the applicant, scrutinizes the information sought, examines its urgency and ensures the disposal of the request within prescribed time period.
- 2. APIO-Assistant Public Information Officer: They co-ordinates with the PIO by all means in receiving and forwarding the applications of the seekers and ensures the delivery of the information to the applicants.
